



**APPLICATION CHECKLIST:
CURRENTLY REGISTERED IN CANADA – NON-PRACTISING**

APPLICANTS CURRENTLY REGISTERED IN ANOTHER REGULATED CANADIAN JURISDICTION

Applicants for the non-practising registration category must be currently registered in the CSASK practising category or be registered in one of the following Canadian regulated jurisdictions: British Columbia, Alberta, Manitoba, New Brunswick, Newfoundland, Nova Scotia, Ontario, Prince Edward Island, or Quebec. Non-Practising registrants may apply to change their status to practising by submitting payment of the required fees, proof of professional liability insurance and other evidence of meeting the requirements for licensure in the practising category.

Non-practising registrants may **not** practice in audiology or speech-language pathology in Saskatchewan in any capacity, including private practice, consultation or mentorship/supervision.

Other registration options for professionals from another regulated Canadian Jurisdiction include:

1. Practising Registration
2. Temporary Registration for visiting clinicians
3. Cross-provincial practice Licence

PRIOR TO STARTING YOUR APPLICATION:

- To avoid delays in processing your application, review the “Registration Requirements and Applications Information” document.
- All application forms are available under the “Application Forms” section at csask.ca.
- Information requested from a third-party, university, regulatory body or college, **must** be sent directly to the CSASK office.
- CSASK will only begin reviewing your application once payment of the **non-refundable** application and assessment fees, and **all** required documents have been received.
- CSASK will notify you if more information is required.

PLEASE NOTE:

- Start the application process early to allow for sufficient processing time, prior to the anticipated employment or volunteer start date.

APPLICATIONS ARE PROCESSED WITHIN 10 BUSINESS DAYS ONCE PAYMENT AND ALL REQUIRED DOCUMENTS ARE RECEIVED.
